## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.22 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.22 per Share, the amount of net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees, commissions and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$32.0 million. The Company intends to apply such net proceeds for the purposes set out in the paragraph headed “Offer Price and Net Proceeds” below in this announcement.

#### Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 8,675 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 2,082,080,000 Offer Shares, representing approximately 83.28 times of the 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to very significant over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 50 times but less than 100 times the number of Offer Shares initially available for subscription under the Public Offer, a total number of 75,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer is 100,000,000 Shares, representing 40% of the total number of Offer Shares initially available under the Share Offer and being allotted to 8,675 applicants under the Public Offer.

#### Placing

- The Offer Shares initially offered under the Placing have been moderately over-subscribed, which is equivalent to approximately 1.67 times of the 225,000,000 Offer Shares initially available under the Placing before reallocation. The final number of Placing Shares allocated to 170 placees under the Placing after reallocation to the Public Offer is 150,000,000 Offer Shares, representing 60% of the total number of the Offer Shares initially available under the Share Offer.

- A total of 58 placees have been allotted ten board lots of the Placing Shares or less, representing approximately 34.12% of the total number of placees. These placees have been allotted approximately 1.43% of the 150,000,000 Offer Shares available under the Placing. A total of 50 placees have been allotted five board lots of the Placing Shares or less, representing approximately 29.41% of the total number of placees. These placees have been allotted approximately 0.93% of the 150,000,000 Offer Shares available under the Placing.
- The Offer Size Adjustment Option has not been exercised by the Sole Bookrunner and has accordingly lapsed.
- The Directors confirm that, to the best of their knowledge, information and belief having made reasonable enquiries, all placees under the Placing and their ultimate beneficial owners are independent and not connected person of the Company and any of the Directors, chief executive or Controlling Shareholders, substantial shareholders, significant shareholders or existing shareholders (as defined in the GEM Listing Rules) of the Company or any of its subsidiaries, and their respective close associates (as defined in the GEM Listing Rules), and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Placing Shares subscribed by the placees has been financed directly or indirectly by any of the Directors, chief executive or Controlling Shareholders, substantial shareholders, significant shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees is accustomed to taking instructions from any of the Directors, chief executive or Controlling Shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. None of the Sole Sponsor, the Sole Bookrunner, the Lead Manager, the Co-Lead Manager, the Underwriters and their affiliated companies and the connected clients (as defined in note 2 to Rule 10.12(4) of the GEM Listing Rules) has taken up any Offer Shares for its own benefits under the Share Offer. The Directors confirm that the three largest public Shareholders of the Company do not hold more than 50.0% of the Shares held in public hands at the time of the Listing in compliance with the GEM Listing Rules.

Based on the Offer Price of HK\$0.22 per Offer Share, the amount of net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees, commissions and estimated expenses payable by the Company in connection with the Share Offer (the “**Net Proceeds**”), is estimated to be approximately HK\$32.0 million.

The Group intends to apply the Net Proceeds for the following purposes:

- approximately HK\$13.5 million (representing approximately 42.2% of the net proceeds) for broadening the existing customer base, increasing the Group’s market share in the existing target markets and expanding into new markets, among which approximately HK\$3.6 million for refurbishing the existing office and showroom in the PRC and approximately HK\$9.8 million for establishing one liaison office in each of Europe and the US;
