This announcement is made by Satu Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review of the currently available unaudited consolidated management accounts of the Group for the year ended 31 March 2020, it is expected that the net loss before tax for the year ended 31 March 2020 increased by approximately 69% compared to that for the year ended 31 March 2019. The increase in expected loss is mainly due to (i) a decrease in sales orders from one of the major customers; (ii) a lower gross profit margin recorded; and (iii) an increase in the depreciation of property, plant and equipment.

The Company is still in the process of finalising the Group’s annual results for the year ended 31 March 2020. The financial information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the unaudited consolidated management accounts of the Group for the year ended 31 March 2020 and the information currently available as aforementioned, which has neither been audited nor reviewed by the independent auditor of the Company, and is therefore subject to possible change and adjustment upon further review. Shareholders and potential investors are advised to read carefully the results announcement of the Company for the year ended 31 March 2020, which will be published in June 2020 in accordance with the requirements of the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
